




1. British Red Cross	Both the International Federation of Red Cross and Red Crescent Societies (IFRC) and International Committee of the Red Cross (ICRC) have launched emergency appeals for its operations in Ukraine and neighbouring countries. ICRC's response is targeting the support of health facilities, the provision of medical equipment and food as well as reuniting separated families. The IFRC will focus assisting an initial 2 million people in need with a special focus on vulnerable people, including unaccompanied minors, single women with children, elderly, and people with disabilities. Funds will increase capacity building of Red Cross teams in Ukraine and neighbouring countries to bolster locally led humanitarian action.	£120,000.00	Inside Ukraine	Grant paid
2. Crown Agents	4,000 trauma kits delivered to Ukraine. Crown Agents have been contacted by the Ukrainian Ministry of Health with an urgent request for the purchase and distribution of 50,000 medical trauma kits. Getting supplies into the country is becoming increasingly more difficult and dangerous. Through their previous experience in procuring Covid-19 vaccines and kits for the Ukrainian Ministry of Health (MoH), Crown Agents have relevant ties with the Ukrainian Government as well as a team on the ground in Ukraine, Poland and Slovakia. Crown Agents have estimated these kits can reach their intended destination within 96 hours of receiving funds. Jersey funds will secure 4,000 kits.	£400,000.00	Inside Ukraine	Grant paid
3. Normandy Trader Humanitarian Convoy	Transportation of Jersey goods to Poland	£9,380.00	Neighbouring countries	Grant paid
4. OCHA - Ukraine Humanitarian Fund (UHF)	The Ukraine Humanitarian Fund (UHF) is addressing 3 priorities: 1 - Provide timely lifesaving multisectoral assistance to displaced and non-displaced persons, who are affected by the escalation of hostilities. 2: Protect conflict-affected people and civilian infrastructure regarding international humanitarian law, norms, and standards. 3: Support provision of basic services in areas impacted by the escalation of hostilities.	£120,000.00	Inside Ukraine	Grant paid
5. UNHCR	UNHCR is coordinating leads and coordinates the implementation of the inter-agency Regional Refugee Response Plan with partners both at regional and country level to prepare adequately to be able to support governments in their response to a refugee influx through the provision of core relief items and unrestricted cash grants.	£120,000.00	Neighbouring countries	Grant paid
6. Mercy Corps	Mercy Corps' response in Ukraine is focused on improving access to essential information, the provision of household and sanitary items, medical assistance, cash and psychosocial support for refugees, IDPs and other vulnerable communities. This includes supporting targeted populations with access to information to basic services such as legal assistance, protection assistance, transport, accommodation and medical care, using digital technology and capitalising on the widespread use of smartphones by affected populations. In the first phase of the response, Mercy Corps will also work with local organisations already on the frontline of the responses, providing them with small, flexible cash grants that enable them to rapidly respond to the urgent needs of those affected by the conflict.	£150,000.00	Inside Ukraine	Grant paid
7. Humanity and Inclusion	Establishing support services in Moldova: Moldova has now received over 350,000 refugees and of the neighbouring countries is the least equipped in terms of infrastructure and mobilisation of civil society. Providing additional support to H&I not only enables them to realise the original scope of their project, it focuses Jersey's support to a target location with high needs but less prominent than other border points - our funds are likely to have a higher impact, especially as hostilities increase in the south. Rather than spreading available funds thinly over multiple projects, there is value in focusing on specific geographies and/or specific themes. Jersey's support will not only benefit 3,000 highly vulnerable refugees (including those with disabilities), our funds will establish support and services that will enable H&I to continue their work beyond the lifespan of the grant. Key activities include providing information and orientation to refugees, physical and functional rehabilitation services, enhancing existing health facilities and fostering disability-inclusive humanitarian response through evidence-based advocacy and capacity building of humanitarian actors and coordination mechanisms.	£300,000.00	Neighbouring countries	Grant paid
8. Crown Agents	150 high-quality ballistic vests and helmets for medics: Jersey has already provided the Ukraine Ministry of Health with essential medical equipment in the form of oxygen concentrators and trauma kits - supporting front-line doctors and nurses with personal protective kit addresses the urgent needs identified by the MoH and adds to the narrative that Jersey is addressing them. A grant of £200,000 secures 150 vests and helmets, the third item vitally needed to support doctors' lifesaving work in the besieged cities. Crown Agents are excellently placed to ensure the kit is up to spec and to navigate the complicated export licenses and logistics required to get them into Ukraine.	£200,000.00	Inside Ukraine	Grant paid
9. Ukraine Ministry of Health	Jersey Post and Jersey Overseas Aid are delivering 200 oxygen concentrators, which can be used as backup to provide oxygen to patients. The unused equipment was originally bought for the Covid response in the island. Jersey Post will deliver the equipment, which was provided by Jersey's health and community services department, to a warehouse in Poland. From there, international development agency Crown Agents, which has been working in Ukraine for 25 years, will ensure it gets to medical teams and hospitals inside Ukraine.	£0.00	Inside Ukraine	N/A

RedR	Following a Learning Needs Assessment, RedR are proposing to launch a learning programme to improve skills and knowledge of local actors (local orgs, municipalities, community-based organisations and faith-based organisations) responding to the Ukraine crises and to bolster locally led principled and effective humanitarian action. Topics will include, among others Coordination, Protection (including GBV, child protection and prevention of sexual exploitation), Mental health and psycho-social first aid, Understanding the minimum standards of humanitarian assistance, Humanitarian principles and Logistics. Learning format will be a combination of short (35-40min) on-line and off-line learning, pre-recorded webinars and a short facilitated on-line course. The learning programme will be delivered in English and/or local languages with downloadable material translated into Ukrainian, Russian, Polish and Romanian. 13. Caritas Kosice	Funds will go towards supporting the vital role of faith-based organisations in the ongoing humanitarian response. Caritas Kosice, along with sister organisations Caritas Sis and Caritas Slovakia, will procure and deliver essential medicines and supplies to the areas of greatest need in Ukraine - currently anticipated to be the Donbas and the south-east. The intervention will also procure, warehouse and distribute foodstuffs and non-food items to Internally Displaced Persons (IDPs), and expand the provision of psycho-social care to Ukrainian refugees in eastern Slovakia and IDPs in Ukraine.	£125,000.00	Ukraine and Slovakia	Agreement in Progress
14. Crown Agents	Crown Agents have identified the supply of highly mobile and robust incubators inside Ukraine as an urgent need and will procure specialist incubators to address the impact the invasion is having on neonatal care. The incubators will provide essential care for premature babies in highly challenging environments and are an innovative solution to the needs on the ground - they are compact, highly transportable, energy efficient and can run off an alternative power source. Through their previous experience in procuring Covid-19 vaccines and kits for the Ukrainian Ministry of Health (MoH), Crown Agents have relevant ties with the Ukrainian Government as well as a team on the ground in Ukraine, Poland and Slovakia and have supplied various essential medical supplies to medical facilities inside Ukraine since the invasion began, including emergency trauma kits and ballistic vests and helmets with Jersey funds.	£200,440.00	Inside Ukraine	Agreement in Progress
15. Friends of Ukraine EOD	The scale and frequency of Russian bombardment means there is a large amount of unexploded ordnance as well as abandoned ammunition and damaged military hardware throughout the country that poses a real threat to life. Friends of Ukraine - Explosive Ordnance Disposal (FoU-EOD) will train 10 Ukrainian nationals from INGOs and Government agencies (including the Emergency Services, Police and MoD) in accredited Conventional Munition Disposal in specialists training centres outside Ukraine.
